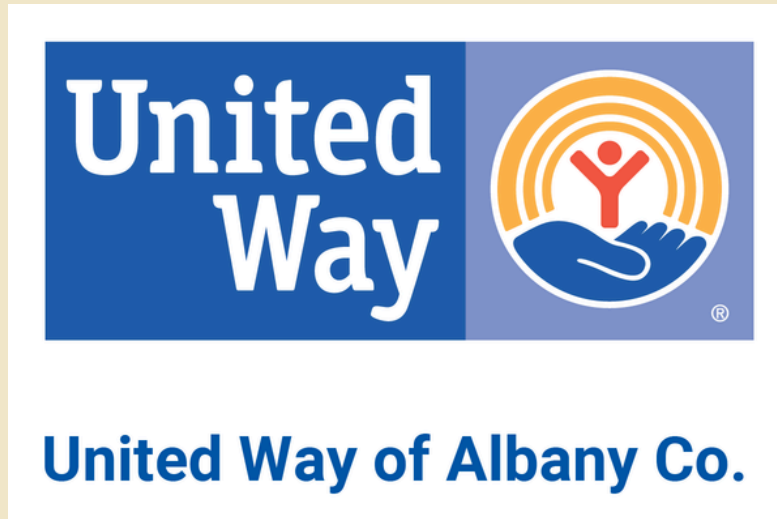

IMPACT OF UNITED WAY OF ALBANY COUNTY SPONSORED PROGRAMS

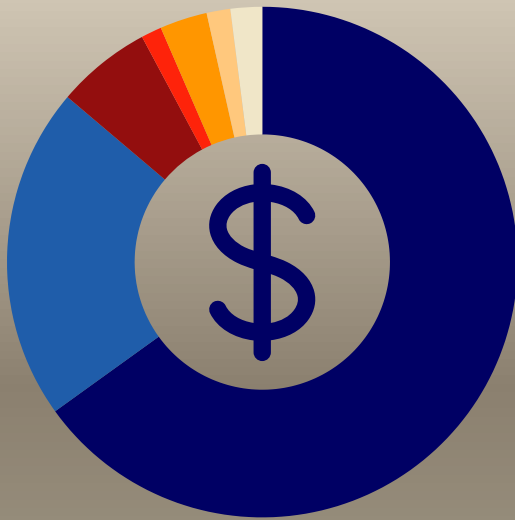
VITA Free Tax Preparation

- Over 550 Tax Returns were completed through VITA clinics for the 2024 Tax Year
- An average of 40 returns were completed per clinic
- The program was supported by 24 student volunteers throughout the duration of the program
- The average adjusted gross income (AGI) of individuals served was \$35,000

COLLECTIVE IMPACT OF OUR COMMUNITY PARTNERS

- Over 11,400 individuals served in Albany County, ages ranging from birth to 65+
- 69% of individuals served were at or below the poverty line
- Our Community Partners coordinated 1,262 volunteers for 121,584 volunteer hours
- Local students have access to direct services, along with internships, volunteer hours, and employment opportunities through our Community Partners.
